9) Hold Harmless. Buyer understands that there are risks incident to such performances/lessons and understands and acknowledges that he or she is aware of and understands and agrees, that Buyer fully assumes all such risks. Buyer agrees that neither PG nor any of its owners, suppliers, proprietors, managers,

partners, members, officers, directors, shareholders, employees or agents (collectively, Sarah Chang LLC dba Wanna Hula) nor the providers of third party services and their respective owners, suppliers, proprietors, managers, partners, members, officers, directors, shareholders, employees or agents shall be liable for any death, injury, sickness, damage, accident or other loss arising out of any said performances/lessons. Buyer hereby releases and forever discharges PG from and against any and all liability for any death, injury, sickness, damage, accident or other loss which arises out of, occurs during or is related in any way to Buyer and Buyer's clients'/ guests'/ attendees' participation in or attendance to any of the said performances/lessons even if PG has been advised of the possibility of such damages, arising from or related to any service provided by PG in connection herewith, or the failure of PG to perform its obligations, regardless of any negligence by PG.

10) Limited Liability: Buyer agrees that PG nor any of its third party service providers are responsible in any way direct or indirect, consequential, special or exemplary damages even if PG and its third party service providers have been advised of the possibility of such damages, arising from or related to any service provided by PG or its third party service providers. Buyer agrees to be fully liable for any death, injury, sickness, damage, accident or other loss. In no event will the aggregate liability to PG (collectively, Sarah Chang LLC dba Wanna Hula) with regard to the services provided in connection herewith exceed the compensation paid by Buyer to Sarah Chang LLC dba Wanna Hula. Buyer's right to monetary damages up to that amount will be in lieu of all other remedies that Buyer or any of Buyer's authorized users, customers or clients have against PG.

11) Accommodations. Buyer shall provide each member of PG with:

- Reasonable amounts of free water and soda during the Performance/Lesson.

12) Cancellation. If Buyer cancels the Performance/Lesson before the Date of Performance/Lesson, Buyer shall pay PG, by the Performance/Lesson Date 100% of the deposit and balance plus any additional incurred fees as liquidated damages . The obligation of PG to perform/give lessons shall be excused by detention of personnel by sickness, conflicts, accidents, riots, strikes, epidemics, acts of God, Force Majure or any other legitimate condition beyond the control of PG.

13) Harassment: PG will not tolerate harassment of any kind or any unsavory behavior toward PG by attendees of any event. If this occurs, the undersigned agrees that PG will be free to leave the event at PG's discretion and still will be fully compensated for the full amount of the contract plus damages.

14) Media Policy and Release: PG and its third party service providers routinely promote activities through media. This includes, but is not limited to pictures, video, newsletters, newspapers, brochures, displays, and web pages. Buyer understands that any pictures, video, names may be included and that comments and feedback may be used as testimonials. (Youth will not be identified by name.)

15) General. This Agreement will be governed and construed in accordance with the laws of the State of Hawaii. This Agreement constitutes the entire Agreement between the Parties.
